# **1.** Contract

- **1.1** This Master Policy is a contract of insurance between **Prudential Assurance Uganda Limited** (hereinafter referred to as "the Company or PAUL") and **THE REGISTERED TRUSTEES OF CHURCH OF UGANDA** implementing a Kingdom Development Organ KIDO programme (hereinafter referred to as "KIDO").
- **1.2** The Proposal form, Policy schedule, Table of benefits, Membership cards issued and, written and agreed amendments form part of the contract and must be read together with this Policy. Any word or expression to which a specific meaning has been attached shall bear that specific meaning wherever it may appear. No change in this Policy shall be valid unless approved by an authorized representative of both parties and evidenced by endorsement or amendment thereon or attached thereto.
- **1.3** The information provided to the Company by or on behalf of the KIDO, Insured member and/or their Dependents on the Proposal form and Policy addenda thereto is the basis of this contract and is deemed to be incorporated in this Policy. The truth of the information and answers in the Proposal form shall be conditions precedent to the Company's liability to make payment under this Policy. This information is not limited to only pre-existing or chronic conditions. The Insured member shall be the paid-up subscribers of the Kingdom Development Organ (hereinafter referred to as "the subscribers or insured member") under the Trustees of the Church of Uganda and their dependants.
- **1.4** The Company has availed a list of networks of hospitals and clinics across the country (hereto attached) and it shall form an integral part to this contract and is subject to revision by PAUL during the contractual period upon notice.
- **1.5** The insurance cover provided shall be determined by applying the rules defined herein together with the Policy schedule, Table of benefits and Membership cards issued to the KIDO. Any benefit not shown in the Policy schedule, Table of benefits and Membership cards is not provided for under this Policy. The KIDO shall examine this Policy, Policy schedule, Table of benefits and Membership cards and Membership cards carefully to make sure the required protection has been provided. Each insured life under this policy shall be issued a Membership card for their sole use. No other individual whether insured or not shall use another individual's membership card.
- 1.6 In consideration of the KIDO's payment of the Premium in full, and upon the receipt of proof of Claim, the Company undertakes to pay for all Eligible medical expenses of acute phases of illnesses or Accidents incurred by Insured members during the Policy period, subject to the terms, conditions, and exclusions of this Policy.
- **1.7** For the entirety of duration of this Policy, the use of masculine pronouns shall be deemed to indicate both masculine and feminine and the singular shall be deemed to include the plural and vice versa, where appropriate.

## **1.8 RESPONSIBILITIES OF THE PARTIES**

#### 1.8 a) Joint Responsibilities.

Each Party shall appoint a contact person responsible for coordinating its activities under this Agreement. The appointed contact persons shall have the following responsibilities:

- i) Act as a primary liaison to ensure that the objectives of the Parties as set forth in this Agreement are met.
- ii) Deal with all issues arising out of the implementation of the terms of this Agreement or otherwise relating to the Policy.
- iii) Ensure effective communication in order to discuss the progress of the implementation of the HealthInsurance Cover to the Insured on a regular basis.
- iv) handle general complaints and disputes relating to the interpretation of this Agreement.

Either Party may remove or replace a contact person appointed by it by written notice to the other Party which notice

shall state the name of the replacement contact person for such Party.

## 1.8 b) Responsibilities of the Insured member;

- i) To adhere to the terms and conditions as stipulated in the policy.
- ii) To pay the stipulated medical premiums as per the policy
- iii) To pay the subscription fees of KIDO as per the requirements of the organ before joining this insurance scheme
- iv) An insured member shall be liable for any false or untrue information provided to the company that may cause prejudice.
- v) Utilize the medical cover in a responsible and lawful manner.

#### 1.8 c) Responsibilities of Kingdom Development Organ (KIDO)

- i) KIDO shall represent The Trustees of the Church of Uganda.
- ii) They shall be responsible for:
  - a. Submission of all application forms to PAUL for onboarding of subscribers
    - b. distribution of membership cards to insured members
- iii) To oversee the roll out of the scheme and ensure its growth in co-dordination with the appointed PAUL agent(s).

#### 1.8 d) Responsibilities of The Trustees of the Church of Uganda

- i) Shall be the overall holder of this policy
- ii) To endorse all official communication and
- iii) Consent to any changes to the policy with PAUL.

#### DECLARATION

The parties hereto have executed and delivered this Policy as of the23rd day of November 2023.

#### 2 Definitions and Abbreviations

The following words, expressions or phrases used in the context of this Policy have specific meanings as given below.

- **2.1 Abuse:** means the excessive use of a substance including but not limited to alcohol and drugs. As regard to drugs, this includes use for a reason other than that which it was intended for or in a manner other than as directed or prescribed on medical authority.
- **2.2** Accident: means any sudden and unforeseen event that occurs beyond the Insured member's control during the Policy period, resulting in bodily injury. This excludes accidental illness, surgical procedures and aggravation of a Pre-existing condition.
- **2.3** Acute phase of an illness: means an event characterized by a single episode of fairly short duration, requiring Treatment for normally less than fourteen (14) days, and from which the patient can be expected to return to his normal or previous state and level of activity.
- **2.4** Allopathic medicine: means the type of medical care that uses substances, surgery, and Treatments specifically targeted against the Illness and intended to cure the Illness. This term is generally used to describe the conventional (or Western) approach to medicine.
- **2.5** Alternative medicine: means types of medical care that are alternative to the conventional Allopathic medicine covered under this Policy.
- **2.6 Annual maximum limits:** means the total amount that may be claimed in any one (1) Policy period by an Insured member. These limits are shown in the Table of benefits.
- **2.7 Birth defect:** means any deformity/abnormal condition or anomaly, or disability of a person arising during the antenatal stages of pregnancy or caused by/or during childbirth.
- **2.8 Bodily injury:** means an identifiable physical injury which is sustained while this Policy is in force and which occurs anywhere in the world; and which solely and independently of any other cause, results in the insured requiring and/or seeking medical care.
- 2.9 Chronic condition: means a disease, illness or injury which has at least one of the following characteristics:
  - a. no known cure or fails to respond to treatment
  - b. is recurrent in nature
  - c. leads to permanent disability
  - d. is caused by changes to one's body which cannot be reversed
  - e. requires one to be specially trained or rehabilitated
  - f. needs prolonged supervision, monitoring or treatment including palliative care.
- **2.10** Claims: means a notification to the Company requesting for payment of an amount due to the Provider under the terms of this Policy.
- **2.11 Claim form:** means a document issued by the Company which shall be used by the Provider and Insured member to set out information in respect of the Claim incurred.
- **2.12 Claims Ratio**", "Medical claims ratio" or "MLR": means the ratio of claims incurred to premiums earned per contract expressed either as a ratio or as a percentage. This item shall be determined solely by PAUL's Finance and Technical departments.
- **2.13 Commencement date:** means the date, shown in the Policy schedule and the Membership card on which cover under this Policy commences.
- 2.14 Company: means Prudential Assurance Uganda Limited.
- **2.15 Consultant:** means a Secondary care specialist duly registered and licensed by the Uganda Medical and Dental Practitioners Council and who, in carrying out such specialist treatment, is practicing within the scope of his licensing and training.
- **2.16 Consultation:** means any medical advice from or encounter with a Physician or Consultant including the issue of any prescriptions for investigations and medications.
- 2.17 Customary and Reasonable Charges: Means charges for medical care made by a service provider which shall be considered by Prudential to be customary and reasonable to the extent that they do not exceed the general level of charges being made by other service providers of similar standing in the locality where the charge is incurred when providing like or comparable treatment, services or supplies to individuals of the same sex and of comparable age, for a similar disease or injury. The scales of charges agreed from time to time between Prudential and the Panel of Service Providers shall be indicative of such customary and reasonable charges.
- **2.18 Dentist:** means a registered or licensed dental practitioner who is legally authorized to practice dentistry by the Uganda Medical and Dental Practitioners Council.

- **2.19 Dependent:** means the Insured member's spouse, children, adopted children and stepchildren who are eligible for coverage according to the Eligibility conditions set forth in this Policy.
- **2.20 Designated providers:** means Hospitals, clinics, laboratories, diagnostic centers and pharmacies with whom the Company has agreements to provide covered benefits, in accordance with the terms of this Policy, to the Insured members and are included under the list of Registered Healthcare providers attached to the Policy schedule.
- **2.21 Diagnostic procedures:** means any tests for diagnosing Illness, including pathology, laboratory, x-ray, ECG, medical scanning and imaging techniques and interpretation of the results by a Physician or Consultant.
- **2.22** Due date/Renewal date: means the date of renewal of cover as shown on the Policy schedule and the Membership card, or the date on which any subsequent installment of Premium falls due.
- **2.23** Elective: Means Planned Treatment, which is medically necessary, but which is not required as an emergency.
- **2.24 Eligible medical expenses:** means medical, surgical, or any other expenses necessarily incurred by an Insured member in relation to benefits eligible for coverage under this Policy. These could involve specified medical services' fees or other reasonable and customary charges.
- **2.25 Emergency:** means an injury or Illness which happens suddenly and whose acute symptoms are of such severity that the absence of Treatment within twenty-four (24) hours is medically expected to result in a serious threat to the life, health, bodily function and/or organ of the patient.
- **2.26 Endorsement:** means a contractual document issued by the Company subsequent to this Policy, introducing alterations to this Policy in full conformity with its provisions.
- **2.27 Epidemic/Pandemic:** An epidemic is the rapid spread of infectious disease to a large number of persons in a given population within a short period of time. An epidemic may be restricted to one location; however, if it spreads to other countries or continents and affects a substantial number of people, it may be termed a pandemic.

A pandemic is an epidemic occurring on a scale which crosses international boundaries and usually affecting a large number of people.

- **2.28** External Prosthesis: An artificial device that replaces a missing body part, which may be lost/absent through trauma, disease, or congenital conditions such as a prosthetic limb, ear which is required at time of a surgical procedure.
- **2.29** Excess: means a specific amount or percentage of Eligible medical expenses that must be incurred and paid for by the Insured member before benefits are payable under this Policy.
- **2.30 Expiry date:** means the date, shown in the Policy schedule and the Membership card on which cover under this Policy ceases.
- 2.31 Fraud: is an intentional Act of deception by any person which has the objective of:
  - g. Obtaining a (financial or other) benefit or advantage relating to the health insurance/administration under this agreement
  - h. Causing or exposing another person to a (financial or other) loss or disadvantage related to the operation of this agreement, whether or not that act in fact achieves its intended purpose
- **2.32 General exclusions:** means excluded Illnesses, items, Treatments, procedures and their related or consequential expenses, which are not covered under this Policy. These exclusions are shown in the General exclusions list.
- **2.33 Genetic Testing:** any type of medical test that identifies changes in chromosomes, genes, or proteins, the results of which can confirm or rule out a suspected genetic condition or help determine a person's chance of developing or passing on a genetic disorder.
- **2.34 Home Nursing:** Medically necessary home nursing care shall be provided upon approval by Prudential. This shall be covered up to a maximum of 30 days in any policy year.
- **2.35** Hospital: means any institution established for inpatient and/or outpatient treatment of sickness and injuries and which has been registered as a Hospital or clinic or nursing home with the Uganda Medical and Dental Practitioners Council and is under the supervision of a registered and qualified Medical practitioner; and maintains permanent and full-time facilities; and has diagnostic and therapeutic facilities for major surgical and medical diagnosis and treatment; and provides nursing service on a 24 hour basis. This shall not include an establishment which is convalescent home, place of rest, place for the aged, a place for drug addicts or a place for alcoholics, a hotel or similar place.
- **2.36 Illness:** means any kind of health condition not otherwise excluded by this Policy which is sustained by an Insured member during the Policy period and occasions the necessity for the Insured member to receive care and attendance from a Physician or Consultant.

- 2.37 Inpatient treatment: means Treatment where the Insured member requires hospitalization for a minimum of one (1) night, for specialized medical attention and care, before, during and after the Treatment. Such Treatments cannot be performed on an Outpatient basis.
- **2.38 Insured member:** means any Insured member or his Dependents who have fulfilled the Eligibility conditions and are named in the Policy schedule and hold a valid Membership card.
- **2.39** Join date: means the date, shown on the Policy schedule on which an Insured member was included under this Policy and becomes eligible for cover.
- **2.40 KIDO:** means the applicant for the insurance coverage, acting in the name of the Insured member and their dependents, whose application is formally accepted by the Company and protection is provided under this Policy.
- **2.41 Maintenance treatment:** means any Treatment or procedure, the primary purpose of which is to offer temporary relief or control of symptoms rather than to cure the Illness causing the symptoms.
- **2.42 Medical expenses:** means all medically necessary and reasonable expenses incurred in respect of medical, surgical and remedial treatment as directed by the Medical practitioner including laboratory, x-rays and other diagnostic charges.
- **2.43 Medical practitioners:** means practitioners who are duly registered and licensed by the Uganda Medical and Dental Practitioners Council and are practicing within the scope of their license.
- **2.44 Medically necessary treatment:** means any medical, surgical or other service that an Insured member requires provided such services are:
  - i. Essential and related to the Illness presented
  - ii. Rendered in accordance with generally accepted medical practice and professionally recognized standards
  - iii. Not Treatments that are generally considered as experimental or unproven
  - iv. Not primarily for the convenience of the patient or physician, or other physician
- **2.45 Membership card:** means a personalized card issued by the Company in the name of each Insured member, identifying him as an Insured member and facilitating his access to the benefits covered under this Policy and provided by Designated providers.
- **2.46** Moratorium period: means the period an Insured member has to wait before he becomes eligible for a benefit. The Moratorium period is determined by the date the Insured becomes a member.
- **2.47 Newly diagnosed condition:** means any bodily injury or illness or its related condition that did not medically exist prior to the enrolment date of the Insured member and necessitates the Insured member to receive care or Treatment.
- 2.48 Non-designated providers: means Hospitals, clinics, laboratories, diagnostic centers and pharmacies with whom the Company has no agreement to provide covered benefits, in accordance with the terms and conditions of this Policy, to the Insured members and/or are not included under the list of Designated providers in the Policy schedule. Benefits received at such Providers will be on a reimbursement basis subject to prior approval from the Company at customary and reasonable rates.
- **2.49 Outpatient treatment:** means all medically necessary treatments and services that do not require hospitalization during the day or overnight nor necessitate specialized medical attention.
- **2.50 Overall limit:** means the maximum amount that an Insured member may Claim during the Policy period for all the benefits covered under this Policy.
- 2.51 PAUL: shall mean Prudential Assurance Uganda Limited
- **2.52 Physician:** means a registered medical practitioner who is legally licensed to practice Allopathic medicine by the Uganda Medical and Dental Practitioners Council and who in carrying out such Treatment, is practicing within the scope of his licensing and training.
- **2.53 Policy:** means the documents evidencing the terms, conditions, benefits and price of the cover applicable to the Insured member(s). The Policy consists of:
  - i. The general terms and conditions set out in this document
  - ii. The Proposal form(s) duly completed and signed by the Insured member(s)
  - iii. The Policy schedule
  - iv. The Table of benefits
  - v. Membership cards
  - vi. Endorsements to any of the aforementioned

- **2.54 Policy period:** means the period of this Policy stated in herein and the Membership card from the Commencement date to the Expiry date.
- **2.55 Policy schedule:** means a list issued by the Company in which information on the contractual parties are specified, together with the specific conditions of this Policy including but not limited to the Commencement date, the Expiry date, Policy name and number, Premium and Premium payment details, benefits details (including Annual maximum limits and benefits, annual sub-limits, Excess amounts and percentage of Coinsurance, if applicable), Designated providers list, membership list including Insured members details (name, date of birth, gender and Insured members' Join dates), and the Policy's special conditions, if any.
- **2.56 Pre-authorization:** means review and approval of Treatments by the Company prior to or concurrent with the Treatment date to ensure that they are undertaken within the scope of cover of the Policy terms and conditions, benefits and exclusions.
- **2.57 Pre-existing condition:** means any bodily injury or illness or its related condition that medically exists prior to the enrolment date of the Insured member, whether it is known or not known to him, and necessitates the Insured member to receive care or Treatment.
- **2.58 Pre-hospitalization:** means medically necessary expenses incurred during the period up to seven (7) days prior to hospitalization for disease/illness/injury sustained which will be considered as part of a claim under hospitalization.
- **2.59 Prematurity:** The birth of a baby of less than 34 weeks gestational age, and before the developing organs are mature enough to allow normal postnatal survival.
- **2.60** Post-hospitalization: means medically necessary expenses incurred during the period up to seven (7) days after hospitalization for disease/illness/injury sustained which will be considered as part of a claim under hospitalization.
- **2.61 Insured member:** means a subscriber of the KIDO or any member of a legally established organization or association (e.g. association, union and the like) who has fulfilled the Eligibility conditions and is named in the Policy schedule and on a Membership card.
- **2.62 Proposal form:** means a signed statement of facts made by the applicant for insurance, on the basis of which the Company carries out underwriting in accordance with the terms and conditions of this Policy. The Proposal form becomes part of the contract when the Policy is issued.
- **2.63 Provider:** means any person (Physician or nurse) or institution (Hospital, clinic, medical center, pharmacy, laboratory or other paramedical institution) that is licensed by the Uganda Medical and Dental Practitioners Council to provide Allopathic medicine.
- **2.64 Related condition:** means any Illness considered to be either an underlying cause of or directly attributable to another specific Illness.
- **2.65 Secondary care:** means Treatment delivered by a Consultant following referral for further Treatment from a Physician.
- **2.66 Strike:** A work stoppage by three (3) or more workers to enforce demands made on an employer or to protest against an act or condition.
- **2.67** Surgical Operation: means manual and/or operative procedures for correction of deformities and defects, setting right of injuries, diagnosis and cure of diseases, relief of suffering and prolongation of life.
- **2.68 Table of benefits:** means a schedule issued by the Company showing the extent and nature of benefits, Excess amounts and percentages of Coinsurance applicable under this Policy.
- 2.69 Term baby: a delivery of a baby at 34 weeks or more.
- 2.70 Territorial limit: means the geographical limits within which Treatment may be received.
- **2.71 Treatment:** means a medical or surgical test or procedure the sole purpose of which is to cure an Illness and not to alleviate a long-term Chronic condition.
- 2.72 Waiting period: same definition as moratorium period.
- **2.73 UNEPI Vaccination:** (United Nations Expanded Program for Immunization) shall refer to the following vaccines which are provided for free in Uganda; Polio, BCG, DPT (combined with Hepatitis B and Hemophilia Influenza B (HIB) and Measles.

## 3 Terms and Conditions

**3.1 Policy Period:** This Policy is an annual contract. Subject to the KIDO's payment of the required premium in full, It shall commence on the Commencement date and terminate at the Expiry date, specified in the Policy schedule. The policy may be renewed for further one-year periods subject to the Company's consent and the KIDO's payment of the agreed annual premiums in full.

- **3.2 Pre-Existing conditions:** Any pre-existing medical condition of which a member was aware or ought to have known, prior becoming a Member under this Agreement for the first time, must be declared on the Enrolment Form and Declaration of Health. Such pre-existing condition will be included provided that the condition is not listed as a standard exclusion.
- **3.3** Hospitalisation costs of a new member will not be covered if the member in question is still admitted or was admitted before they joined the scheme.
- **3.4 Eligibility Conditions:** The coverage under this Policy will be provided to all Insured members who fulfill the following conditions.
- **3.5 Insured member:** all the KIDO's subscribed members residing in the Republic of Uganda and shall be subject to the age limits detailed below:

For new members, a person shall qualify for the general medical cover if they are below the age of 70 years by their next birthday. A person who is 70 years or shall be 70 years at their next birthday, shall qualify for the senior citzen medical cover. A new member shall not be eligible for cover if he/she shall attain 80 years at their next birthday.

For continuing members, a person shall qualify for the general medical cover if they are below the age of 75 years by their next birthday. A continuing member who is 75 years or shall be 75 years at their next birthday, shall qualify for the senior citzen medical cover. A continuing member shall not be eligible for cover if he/she shall attain 85 years at their next birthday.

The company may consider a renewal application for medical insurance for a continuing member above 85 years on terms and conditions that it may set. The decision of the company shall be discretionary and final.

- **3.6 Dependents:** The Dependents of the Insured member are eligible for coverage under this Policy, provided they are:
  - i. The legal spouse of the Insured member having attained the age of not more than seventy (70) years (at their first Join date) and is resident in Uganda. Coverage of an insured spouse ends on the date of divorce.
  - ii. The unmarried children, stepchildren and legally adopted children of the Insured member provided they are born term as defined by this policy and were discharged from hospital after birth up to a maximum of eighteen (18) years of age, are residing with the Insured member and are dependent upon him for support. Children aged over eighteen (18) years shall only be eligible if they are full-time students at a school, college or university and are not aged above twenty-five (25) years of age.
  - iii. A Dependent eligible to participate as a Insured member under this Policy shall not be a dependent for the purpose of this Policy.

# 3.7 Members Enrollments

- i. **Insured member:** means a subscribed member of KIDO who has fully paid their premium and incepted by the company.
- ii. **Dependents:** Insured member's Dependents are eligible for coverage upon payment of premium by the insured member for the dependant. The Company may require an explanation and proof of dependency in cases where any already existing dependent is suggested for addition after Commencement date of the medical cover. The Company will exercise its discretion to decline addition until the next renewal or subject the dependent to underwriting.

# 3.8 Addition and deletion of members

i. Addition: KIDO may at any time, upon completing and sending to the Company the duly completed Proposal form (Member Application form), add a new Insured member and his Dependents or new Dependents of an existing Insured member to the Policy.

ii. Such new Insured member and/or Dependents shall become eligible for coverage from the date of the receipt of additional requests and payment of any additional Premium charged by the Company. Premiums for additions will be charged as follows:

- iii. A new child: Can be covered from birth or from the date an adoption is made final as the case may be, provided one or both parents are covered concurrently in the existing Policy. The Company will normally allow the KIDO to add a newborn child without submitting details of their medical history, provided they are added within three (3) months from the birth date. However, if the child was born as a result of any method of assisted conception or if they have been adopted, KIDO will be required to submit full particulars of such child, including the child's full medical history, following which the Company will extend cover to such child provided it is satisfied that the conditions for cover have been met.
- iv. **Deletion:** KIDO may at any time delete a Insured member and their Dependents from the Policy subject to:
  - a) A written request for deletion of the Insured member or any of their Dependents; and
  - b) Return of Membership cards and other materials facilitating Treatment prior to the deletion date.
  - c) The deletion shall be effected from the date of the receipt of the written request for deletion from KIDO.
  - d) The Premium refund relating to any approved deletion shall be calculated in accordance with the following conditions:
- v. No refund will be payable for deleted Insured members or dependents who have registered any Claim with the Company. Insured members who did not register any Claim prior to their deletion date will be issued credit notes proportionately for the period remaining from the deletion date until the Expiry date of the Policy. The Company shall pay the pro-rated refund after sixty (60) days from the deletion date provided no Claims were reported within this period.
- vi. No refund will be payable if Membership cards and other materials facilitating Treatment are not returned within 60 days of deletion. The amount of refund will be reduced proportionately if the return of Membership cards and other materials facilitating Treatment are delayed.
- vii. Covered benefits arising from Accident or Illness occurring during the Policy period for the Insured member or their Dependents shall cease immediately upon his deletion from the Policy.
- **3.9** Medical Examinations: PAUL may at its own discretion require a medical evaluation of any eligible member and his or her eligible dependents. The cost of medical examinations of such kind will be borne by the member.
- **3.10 Premiums:** All Premiums stated in the Policy schedule are payable to the Company in advance of the Commencement and Renewal dates as shown in the Policy schedule.
- **3.11** Payment of the Premium is the Insured Member's sole responsibility. If the KIDO does not make payment on or before the Renewal date, the Company has the right to withhold payment of the Insured Members' Claims and/or access to Treatment or terminate the Policy with effect from the Renewal date.
  - **3.12** The KIDO shall not offset against Premiums due any amount owed by or Claimed from the Company under this Policy or any other agreement.

- **3.13** Administration Charge: The Company reserves the right to make an administration charge of UGX 10,000 for the replacement or re-issue of Membership cards for insured members. Where an insured member requests for a hard copy policy document, the insured member shall be charged UGX 50,000 for the policy document which shall be picked by the insured member from the Company's head office.
- **3.14** All premiums attract 0.5% insurance training levy.

#### 3.16 Renewal

- i. KIDO may renew the Policy each year. The renewals will be subject to the definitions, terms and conditions in force at the time of each renewal.
- ii. **Renewal notice**: KIDO will be issued with renewal terms and instructions of how to proceed with the Policy renewal at least six weeks prior to the Renewal date.
- iii. Disclosure: KIDO is required to disclose material facts or changes prior to each renewal.
- iv. The Policy will not be renewed automatically upon expiry.
- v. If KIDO does not wish to renew the Policy, this must be confirmed to the Company in writing prior to the Renewal date.

#### 3.17 Policy Alteration

- i. KIDO's suggestion to alter any terms and conditions of this Policy other than the ones clearly defined under Article 3 will be considered for incorporation only at renewal of the Policy.
- ii. At renewal of the Policy, the Company also may add or alter any terms and conditions of this Policy including the Premiums or any administration procedures, as it may deem appropriate. However, the Company will only make alterations to reflect any past and foreseeable changes in the medical insurance practice or procedures and the nature and extent of Claims made or likely to be made generally under the Policy. The purpose of such alteration will be to seek, so far as possible, to maintain the same level and type of insurance cover in place whilst ensuring that the insurance cover provided under this Policy remains affordable. The Company can also increase the Premium if any tax levy is imposed.
- iii. The Company reserves the right to change the terms and conditions of, or cancel, this Policy at any time notwithstanding any other provision of this Policy if KIDO or any Insured member has:
  - a) Not acted in good faith or has misled the Company by withholding any material fact to in relation to this Policy;
  - b) Breached the terms and conditions of this Policy; or
  - c) Not paid the Premiums due.
  - d) Fraudulent members will be removed from the policy and amounts paid out for fraudulent claims recoverable from the individual through the company.
- iv. No variation in the terms and conditions of this Policy either by endorsement or otherwise, shall bind the Company in any way unless it is made in writing by a duly authorized officer of the Company.

#### 3.18 Data Protection

The parties shall comply with applicable data protection Regulations. To the extent that either party processes any personal data for and on behalf of the other party, the party shall at all times maintain all technical and organisational security measures to prevent unauthorised or unlawful processing of any personal data supplied to the party by or on behalf of the party and accidental loss or destruction of, or damage thereto; only process personal data for and on behalf of the other party for the purpose of performing the Services in accordance with this Agreement and not transfer any personal data outside of Uganda without the prior written consent of the other party.

#### 3.19 Compliance with Law and Corrupt gifts

The parties warrant, represent and undertake that they are and shall continue to comply with all applicable Regulations and any guidelines made in connection with such applicable Regulations.

In performing its duties under this Agreement, the parties will comply with all applicable anti-bribery and anti-corruption laws and anti-money laundering (and related Regulation and guidance). In particular, the parties hereby acknowledge and agree:

(a) to comply with, the Anti-Corruption Act 2009 of Uganda, the Anti Money Laundering Act, the US Foreign Corrupt Practices Act and the UK Bribery Act, together with any related Regulations and guidance and that it shall not act in such a way that is or could be construed as a violation of these laws and requirements, including but not limited to offering a bribe or making a facilitation payment to a Public Official or to any other party.

(b) that it will ensure that its activities in connection or relating to its obligations under this Agreement will not cause PAUL to be in breach of any anti-bribery and anti-corruption laws and anti-money laundering laws (and related regulation and guidance);

(c) that they will ensure that they have appropriate internal procedures within its organisation to prevent bribery by its workforce and other people under its control; and

(e) if KIDO, in connection with or relating to its obligations under this Agreement, is asked to partake in any activity, that is in violation of any anti-bribery or anti-corruption laws or becomes aware of any such conduct by its workforce or within its control and concerning or relating to this Agreement, the Service provider agrees to immediately report the details of this to PAUL.

PAUL shall have the right to terminate this Agreement on no notice, without liability, for any perceived or actual breach of this Clause.

## 3.20 Confidentiality

The parties shall only store, copy or use Confidential Information to the extent necessary to perform its obligations under this Agreement.

Except with the disclosing Party's prior written consent, the Parties undertake to keep secret and strictly confidential and shall not disclose Confidential Information to any third party for the duration of this Agreement and thereafter and shall not use such Confidential Information other than for the purpose of performing their respective obligations under this Agreement.

Either Party may disclose Confidential Information to its affiliates, insured members, agents, employees or sub-contractors who need to know about such Confidential Information. Each Party shall ensure the compliance by its Affiliates, insured member, agent, employees or sub-contractors with the obligations of that Party under this Clause.

The provisions above shall not apply to any information which:

- i. is in the possession of either Party without any obligations of confidence in relation to use or disclosure prior to the date of this Agreement;
- ii. is in or enters into the public domain other than by breach of this Agreement or any obligation of confidence owed to PAUL.
- iii. is authorised for release by the written consent of the Party; or
- iv. is required to be disclosed by Regulations or by an Authority.

Any breach of this provision on confidentiality may cause PAUL substantial and irreparable damages and, therefore, in the event of any such breach, in addition to other remedies which may be available, PAUL shall have the right to specific performance and other injunctive and equitable relief. The Service provider shall notify PAUL immediately, and co-operate with PAUL on request, upon the Service provider's discovery of any loss or compromise of any of the Confidential Information.

# 3.21 Policy Termination and consequences

- i. This Policy will automatically terminate upon non-payment of Premium on the Renewal date, although the Company may at its discretion reinstate this Policy if the Premium is paid within thirty (30) days of its Renewal date.
- ii. Cover in respect of Insured members shall terminate immediately on the first of the following events:
  - a) On the death of the Insured member; or
  - b) When a Dependent cease to be the Spouse of the Insured member; or
  - c) When the Insured member ceases to be a subscriber of KIDO (in such an event, the Insured's Dependents will also cease to be covered under this Policy); or
  - d) On the day before the Insured member attains the age limits defined above .
- iii. Either party may terminate this Policy at any time, by giving sixty (60) days' notice of their intention of terminating this Policy by registered letter to the other party, in case of KIDO, to its last known address and in case of the Company, to the address provided below. Termination is subject to a pro-rated refund of the Premiums for the remaining period until the Expiry date for all Insured members who have not registered any Claims with the Company. No refund will be payable for Insured members who have registered Claims with the Company.

iv. KIDO shall return all Membership cards and other materials facilitating Treatment before the termination date.

- v. If any of the Insured members commits false or fraudulent Claims or acts fraudulently or purposefully breaches the terms and conditions of the Policy, then the Company has the right to terminate this Policy or delete the Insured member, with immediate effect and forfeit all the benefits and Premiums without prejudice to the Company's other rights.
- vi. Covered benefits arising from Accident or Illness occurring during the Policy period shall cease immediately upon the termination or non-renewal of this Policy.
- vii. **Effective time of termination**: This Policy and all insurance there under shall terminate at 00.01 hours Ugandan time on the Expiry date of the Policy shown in the Policy schedule.
- viii. Where the KIDO has any premium in arrears, that amount shall fall due on notice of the termination.

## 3.22 General Limitations

- i. **Annual maximum limits**: The Company's liability is limited in amount to the Overall limits and Sub-limits stated in the Table of benefits.
- ii. **Cost of Medical Expenses**: The Company's liability with respect to the cost of Eligible medical expenses hereunder claimed is limited to the actual cost or the reasonable and customary charges, whichever is less. Insured members in doubt shall submit to the Company a quotation for the cost of Treatment and seek Pre-authorization before the Treatment is undertaken.
- iii. Territorial Limits: This Policy shall apply to Eligible medical expenses incurred within the Republic of Uganda and extended to outside Uganda for trips not exceeding six weeks on any one visit which would be paid on reimbursement basis unless the Company has indicated in writing that credit is available.

## 3.23 Medical Records

- i. In compliance with applicable laws and regulations concerning medical records, on behalf of the Insured member and their Dependents, the KIDO authorizes the Company to have physical access, including copies of their records which are maintained by the treating Provider, in respect of Treatments incurred under the terms of this Policy.
- ii. The Company agrees to maintain strict confidentiality of such records.

#### 3.24 Recovery

- i. In accordance with the terms of this Policy, the KIDO is liable for all Claims paid by the Company to the providers, for Insured members who use the Membership cards in a Fraudulent manner.
- ii. **The Company** shall exercise its rights to recover from the KIDO amounts paid to Hospitals or clinics on behalf of Insured members or Dependents for which the Company would have otherwise not paid.

#### 3.25 Subrogation

- i. The KIDO and Insured members must give the Company written notification without delay of any claim or right of action against any third party arising out of any circumstances which gave rise to a claim under this Policy and must continue to keep the Company informed in writing and take all steps the Company reasonably require in making a claim upon the other party.
- ii. The Company has full rights of subrogation and may take proceedings in any of the Insured member's name, at its expense, to recover for its benefit the amount of any payment made under this Policy due from any third party responsible for the Eligible medical expenses incurred.

# 3.26 Currency

Premiums and benefits payable under this Policy shall be paid in Uganda and in Ugandan Shillings. Amounts paid or received by the Company in any other currency shall be converted to that currency at the prevailing market rate of exchange at the date such transaction is entered on the Company's books.

# 3.27 Expert Opinion and Arbitration

- i. Any dispute arising out of or in connection with this contract, including any question regarding its validity or termination shall be referred to and finally resolved by arbitration under the ICAMEK Arbitration Rules.
- ii. The Arbitration shall be chaired by one Arbitrator who shall be appointed by written agreement of both parties within fourteen (14) days from the date of notification of the dispute by either party. In case of

any default by either party in the appointment of the Arbitrator, the appointment shall be made in accordance with ICAMEK Arbitration Rules. The decision of the Arbitrator shall be final and binding on the parties.

- iii. The seat of arbitration shall be Kampala; Uganda and the language of the arbitration shall be English.
- iv. Notwithstanding any reference to arbitration herein, the parties shall continue to perform their respective obligations under the Agreement unless they otherwise agree.
- v. The award of the arbitrator shall be final and binding on the parties. Nothing in this Agreement shall prevent or delay a party from making claims or seeking injunctive or interlocutory relief in courts of competent jurisdiction in Uganda.
- vi. The Arbitration shall be governed by and constructed in accordance with the Laws of Uganda.
- vii. Nothing shall preclude a party from seeking interim or urgent relief from any competent court having jurisdiction pending the institution during the course of or pending the outcome of any arbitration proceedings.
- **3.28** Governing Law: This Policy shall be governed by and construed in accordance with the Laws of Uganda.
- **3.29** Legal Status: This Policy is not valid unless accompanied by a stamped and signed Policy schedule issued by the Company.
- **3.30** Enforcement: The Company and the KIDO are the only parties to this Policy. Insured members will have no right to enforce this Policy or any part of it. No variation in terms and conditions of this Policy either by endorsement or otherwise, shall bind the Company in any way unless it is mutually agreed to and made by the duly authorized officers of the Company and KIDO in writing.
- **3.31 Penalties**: This Policy shall not cover any penalties of whatsoever nature.
- **3.32 Assignment:** This policy shall not be assigned without the prior written consent of the parties.
- **3.33** Clerical Error: A clerical error by the Company shall not invalidate insurance otherwise validly in force. A clerical error shall not relieve the parties of their rightful obligations.

# 4 Claims Ratio

- a) In the event that the claims ratio under this agreement is projected to exceed seventy per cent 70% of the contract consideration and/or premium paid, it is agreed that THE COMPANY reserves the right, at its sole discretion to implement any of the following terms, conditions, limitations and exclusions hereof, during the currency of this agreement, which shall be effective for the remaining period of Agreement:
  - i) Including the option to apply and implement a co-pay of not less than 10,000shs per patient per visit.
  - ii) Adjustments in benefits including exclusion of certain cover, limitation of covered amounts, among others.
  - iii) Revision/limitation on the service provider network.
- b) Notwithstanding anything in this agreement, it is agreed that THE COMPANY'S Finance and Technical department's projections will be the only acceptable projections for the purposes of this clause. The projections will be computed as follows:

Claims Loss ratio = Claims incurred / Earned premium.

Earned premium = Gross written premium as a proportion of the period of cover completed as at date of evaluation.

# 5. Force Majeure

5.1 Neither of the Parties shall be held responsible or liable for any loss, damage, detention or delay brought about by force *majeure* or a force majeure event.

- 5.2 For the purposes of this agreement a force majeure event shall include; an act of God, war, earthquake, inevitable accident, fire, lockout, strike or other labor dispute, epidemic, pandemic, endemic, lockdowns, riot or civil commotion, act of public enemy, enactment, rule, order or act of any government or governmental institution (whether local or foreign), or other cause of a similar or different nature, provided that the said cause was not reasonably within the Insurers or the Company's control or contemplation, as applicable. For avoidance of doubt it is agreed that the list of events in clause (2) above is not conclusive.
- 5.3 If either party hereto is materially hampered in the performance of its obligations under this agreement or its normal business operations are delayed or become impossible or commercially impracticable; then, without limiting such party's rights, the party affected by such Force Majeure Event shall have the option, by giving the other party written notice, to suspend its obligations hereunder for an initial duration of up to 3 months [90 working days] which will be subject to extension as the case maybe.
- 5.4 It is agreed that the total duration of any such suspension shall be limited to six (6) months. If at the end of the six months period the force majeure event still persists and the suspension under this provision has not been lifted, either party may, by written notice to the other, terminate this agreement by giving 48 hours' notice in writing to the other party.
- 5.5 Where either Party becomes aware that performance of its obligations under this Agreement is likely to be or has been affected by force majeure, that Party shall immediately give notice to other Party setting out all relevant details of which capacity to perform its obligations under this Agreement is likely to be or has been affected or constrained by force majeure.
- 5.6 The Parties may however mutually agree on an alternative method of performance of this Agreement during the continuance of the force majeure event.

# 6. Claims Administration

# 6.1 Notice of Claim

- 6.1.1 Notice of any Claim must be submitted on a fully completed Claim form along with other supporting documents within a maximum of sixty (60) days from the Treatment date. Supporting documents shall include the following:
  - i. Original prescription
  - ii. Original detailed and dated receipt
  - iii. Pre-authorization form, if applicable
  - iv. Full and detailed medical and diagnostic reports
  - v. Any other medical information that may be deemed necessary by the Company

# 6.2 Settlement of Claims

6.2.1 **Direct Billing**: The Company has an arrangement that allows for direct submission of Claims by the Designated providers. Insured members shall use the facilities of the Designated providers, by presenting their Membership cards to the Designated providers at the time of their visits. If an Insured member pays for the Treatment at a Designated provider, the Company shall only reimburse the KIDO the agreed charges between the Company and the Designated provider.

6.2.2 **Reimbursement:** If an Insured member receives Treatment at a Provider other than the Company's Designated providers, the Company may reimburse the KIDO subject to preauthorization at customary and reasonable rates within fourteen (14) days of provision of a completed claim form along with any other document to support the claim, as specified under Article 6.1.1 being submitted to the Company within a maximum period of thirty (30) days from the Treatment date. The amount paid will be the Reasonable and customary charges for the medically necessary treatments, less any applicable Excess and/or Coinsurance, as specified in the Table of benefits.

# 6.3 Claim Denials

- 6.3.1 The Company has the right to decline or return submitted Claims, under the following conditions:
  - i. Submitting incomplete Claim form
  - ii. Attaching photocopies rather than originals of receipts, prescriptions, diagnostic services or others
  - iii. Member and/or treating Physician's signature and seal is not on the Claim form
  - iv. Treatments or drugs not prescribed by Physicians
  - v. Treatments or drugs that are not medically relevant or necessary for the conditions presented
  - vi. Treatments for which Pre-authorization is required in accordance with the terms and conditions of this Policy, but for which the Pre-authorization has not been obtained
  - vii. Services received are within the General exclusions of the Policy
  - viii. Expenses in excess of the Reasonable and customary charges (as agreed with Provider)
  - ix. Claims are submitted after Sixty (60) days from the date of Treatment
  - x. Expenses exceeding Annual maximum limits
  - xi. Treatments after the Policy has expired
  - xii. Treatment was before the Insured Member's Join date or before the Commencement date

# 6.4 Appeals on Claim Denials

- 6.4.1 Settlement of eligible Claims shall be considered final unless objections along with supporting justifications are received in writing along with relevant reports and facts within a maximum of sixty (60) days from the date of receiving the payment. The Company reserves the right to deny any objections received after the said period.
- 6.4.2 The Company shall review the justifications received and payments for any approved Claims will be made within thirty (30) days from the date the justifications were received.

# 6.5 Pre-authorization

- 6.5.1 The Company shall require Pre-authorization before the Insured member undertakes any Treatment for the following services:
  - i. All Inpatient and Daycare treatments and services
  - ii. All Surgical operations
  - iii. Computerized tomography (CT scan) and magnetic resonance imaging (MRI)
  - iv. Long term medications (more than one month)
  - v. Maternity treatments (inpatient only)
- 6.5.2 For Emergency Treatments, an Insured member must notify the Company within forty-eight (48) hours of his admission or prior to his discharge, whichever is earlier. The Company reserves the right to deny the request for Pre-authorization of the Emergency Treatment, beyond the said forty-eight (48) hours period, if such notice is not provided.
- 6.5.3 Pre-authorization is valid for a maximum period of fourteen (14) days from the date of issue. The Insured member shall obtain a new Pre-authorization, if he does not utilize it within the said fourteen (14) day period.

- 6.5.4 Notwithstanding Article 6.5.3, the Pre-authorization shall expire automatically on the Insured member's deletion date or with the termination of this Policy.
- 6.5.5 Pre-authorization does not guarantee either payment or the number of Claims. Eligibility for and payment of Claims are subject to review of detailed medical reports, investigation results, diagnostic results, discharge summary, medically necessary treatment and all the terms, conditions, provisions and exclusions of the Policy.

#### 6.6 Prescriptions

6.6.1 Where necessary and when the treating Medical Practitioner does not have the prescribed medicines, the Hospital/clinic shall provide a prescription to the Insured to procure such medicines from a Pharmacy registered with the Company.

#### 1.7 Contribution:

If at any time, any claim arises under this Policy and there be any other insurance covering the Insured member for medical expenses, the Company shall not be liable to pay or contribute more than its rateable proportion of any such claim in connection therewith.

#### 8. Summary of Benefits

#### (A) In-patient Cover

#### i. Hospital treatment and services:

All necessary and eligible medical treatment and services provided by or on the order of a Physician to the Member when admitted as a registered patient to a hospital.

Cover includes hospital accommodation (up to the cost of the agreed bed in that hospital), nursing care, diagnostic, laboratory or other medically necessary facilities and services, physician's, surgeon's, anaesthetist's or physiotherapist's fees, operating theatre charges, intensive care unit charges, high dependency unit, cardiac care unit, specialist consultations or visits and all drugs, dressings or medications prescribed by treating physician for in-hospital use. This shall include discharge drugs for up to 7 days. The cost of non-medical goods or services including such items as telephone, newspaper, toiletry items or accommodation for the Member's family is excluded.

The policy will cover accommodation for a parent or legal guardian accompanying a member who is below 12 years of age.

#### ii. Day Care Surgery or treatment:

When an Insured Person is admitted to a hospital and uses a Hospital Bed but does not stay overnight.

#### iii. Chemotherapy

The treatment of disease such as cancer by the use of chemical substances through cytotoxic and other drugs shall be carried as inpatient or day case based on the treatment required.

### iv. Pre-Hospitalisation Diagnostic Services:

Laboratory, radiology or other necessary medical diagnostic procedures ordered by a Physician, and which results in the Member being admitted (on the same day the tests are done) as a registered patient to a hospital for treatment of the specific medical condition diagnosed, provided that such medical condition is covered.



### v. Local Road and Air Ambulance Services:

Ambulance services for transportation of a sick Member for eligible inpatient treatment from an area where facilities for adequate care do not exist to the nearest suitable hospital or licensed medical facility will be covered within the annual inpatient limit.

vi. Home Nursing: Medically necessary home nursing care shall be provided upon approval by Prudential. This shall be covered up to a maximum of 30 days in any policy year. Cover for all eligible in-patient services is subject to the limits specified in the Schedule and to the treatment cost being reasonable and customary.

#### (B) Inpatient dental

Dental hospitalization requiring justifiable admission in a hospital. Cover includes hospital accommodation (up to the cost of the agreed bed in that hospital), nursing care, diagnostic, laboratory or other medically necessary facilities and services, surgeon's, anaesthetist's, operating theatre charges, intensive care unit charges, high dependency unit, cardiac care unit, specialist consultations or visits and all drugs, dressings or medications prescribed by treating dental surgeon. This benefit will be covered within the inpatient limit to the amount stated of the table of benefits for planned cases and full limit for accidental cases.

#### (C) Inpatient optical

Optical hospitalization requiring justifiable admission in a hospital. Cover includes hospital accommodation (up to the cost of the agreed bed in that hospital), nursing care, diagnostic, laboratory or other medically necessary facilities and services, surgeon's, anaesthetist's, operating theatre charges, intensive care unit charges, high dependency unit, cardiac care unit, specialist consultations or visits and all drugs, dressings or medications prescribed by treating ophthalmologist. This benefit will be covered within the inpatient limit to the amount stated on the table of benefits planned cases and full limit for accidental cases.

### (D) Out-patient Cover

If purchased, this benefit will cover medically necessary and eligible medical treatment provided to a member who is not a registered in-patient at a hospital and defined as:

### i. General Out-patient Services

Outpatient services provided by or on the order of a Physician who is licensed as a General Practitioner.

### ii. Specialist Out-patient Services

Outpatient services provided by or on the order of a Physician who is licensed as a Specialist or Consultant and to whom the Member has been referred to by a General Practitioner.

### iii. Out-patient Laboratory and Radiology Services

Laboratory testing, radiographic procedures used to diagnose or treat medical conditions. Such services must be provided or ordered by a Physician and must be covered under the policy.

iv. Radiation therapy:



Treatment with high-energy radiation rays such as gamma rays are used to kill, shrink, damage cancer cells, and stopping them from growing and dividing is covered under outpatient.

## v. Out-patient Prescription Drugs

Dressings, Drugs and medicines, the use of which is restricted to the order of a Physician and prescribed for use by the Member as an outpatient for a maximum period of one month.

### vi. Other Out-patient Services

Other services rendered under outpatient include physiotherapy which shall be on referral basis by a Physician and vaccinations for children in accordance with the Ministry of Health Uganda National Expanded Programme for Immunisation (UNEPI).

Cover for all eligible outpatient services are subject to the amounts specified in the Schedule and to the treatment cost being customary and reasonable.

## (E) Maternity Cover

# 1. Pregnancy and childbirth

Prudential Insurance will cover the Member for the proportion of expenses shown on the Policy Data Page arising from childbirth provided the Member is admitted in a hospital. The benefit shall cover delivery fees, consultation and treatment for childbirth for the normal period of confinement/admission in hospital.

# 2. Complications of pregnancy

Prudential Insurance will also cover costs arising out of complications of pregnancy, miscarriage and abortion provided that any such abortion shall be certified by a physician and/or a psychiatrist as being necessary to preserve the mental and/or physical health of the mother. Prudential Insurance reserves the right to require the mother to be examined by a specialist of its choice. This benefit is not available for dependent children.

Complications of pregnancy are defined as those medical conditions which only ever arise as a direct result of pregnancy or childbirth. Conditions covered are ectopic pregnancy, gestational diabetes, hydatidiform mole and/or molar pregnancies, miscarriage (actual or threatened), pre-eclampsia, failure to progress in labour or stillbirth. Puerperal psychosis, Post-partum haemorrhage and retained placental membrane that occur during childbirth are also covered by this benefit including complications of the above conditions. Complications arising as a result of assisted conception including but not limited to, premature or multiple births are excluded from this benefit. The policy will however provide for an additional benefit within the mother's inpatient benefit limit to cater for expenses arising from and relating to prematurity of which amount will be stated in the Table of benefits

### 3. Pre-natal and post-natal care

These two benefits though associated with maternity will be covered under the outpatient benefit. This benefit will cover standard prenatal treatments and examinations including 3 routine ultrasounds and the necessary blood works and post-natal check-ups for up to six weeks (6) after delivery, shall be covered within the outpatient benefit of the mother.



Cover for all eligible maternity services are subject to the limits specified in the Schedule and to the cost of treatment being customary and reasonable.

Only principal members and spouses are eligible for maternity cover.

## (F) Optical Cover

If purchased, Prudential Insurance will cover the Member for the proportion of expenses shown on the Policy Data Page for the cost of consultation by an optometrist or ophthalmologist, one sight/vision eye test each membership year, prescribed spectacles, which are prescribed to correct a sight/vision problem such as long or short sight provided that the total coverage under this section in any one period of insurance shall not exceed the limits specified in the Schedule. The frames shall be limited to one pair for every two years (2).

Prudential Insurance shall not be liable for payments in respect of:

- i. The replacement of frames unless directly caused as a result of an accidental injury.
- ii. The replacement of lenses unless necessitated in the course of further treatment in connection with the contingency insured hereby.
- iii. Sunglasses and Plano lenses prescribed or otherwise

Cover for all eligible optical benefits are subject to the limits specified in the Schedule and to the cost of treatment being customary and reasonable.

### (G) Dental Cover

If purchased, Prudential Insurance will cover the Member the proportion of expenses shown on the Schedule for the cost of dental consultation resulting in examinations, tooth cleaning, normal compound filling (excluding the use of semi-precious or precious metals), simple or non-surgical extractions, root canal treatment, inclusive of anaesthetist's fees, hospital and operating theatre costs.

Prudential Insurance shall not be liable for payments in respect of:

- i. The cost of replacement or repairs of old dentures, bridges and plates unless damage to the said dentures, bridges and plates arises as the result of bodily injury sustained by the Member caused solely and directly by accidental external and visible means.
- ii. The cost of orthodontic treatment of a cosmetic nature unless such treatment becomes necessary as the result of bodily injury sustained by the Member caused solely and directly by accidental external visible means or as a result of disease other than normal decay.

Cover for all eligible dental benefits are subject to the limits specified in the Schedule and to the cost of treatment being customary and reasonable.



### (H) Excess of Loss Cover

On written request from the group and at additional premium Prudential Insurance will cover expenses incurred by a member after the limits specified under the in-patient cover on Policy Data Page has been exhausted subject to the conditions as listed below.

- i. The cover limit will be as shown in the table with the respective sub-limits per person per annum.
- ii. The minimum inpatient limit shown must be in place for the Group Excess of Loss cover to apply.
- iii. Prudential Insurance's maximum liability as regards pre-existing, chronic conditions and HIV/AIDS and related conditions and/or any other condition with a sub-limit, will be limited to the amounts specified under the basic inpatient limit and shall not extend to the Group Excess of Loss cover.

The maximum liability shall not exceed the limit for this section as specified in the Schedule including the group limit and is subject to treatment costs being customary and reasonable.

## (I) Funeral Expense Cover

Prudential Insurance shall, upon written notification of the death of a Member while this Policy is in force, pay to the Insured or such other person or persons as the Insured may in writing direct, the amount specified in the Schedule to cater for the funeral expenses.

The benefit shall not extend to coverage of still births or deaths in womb before term.

The maximum liability shall not exceed the limit for this section as specified in the Schedule.

### 9. Moratorium/Waiting period

- i) Outpatient Services will be provided under this scheme from the commencement date.
- ii) Inpatient (Hospitalisation) Services will be provided under this scheme after three (3) months from the commencement date.
- iii) Maternity Services will be provided under this scheme after eight (8) months from the commencement date.
- iv) Pre-existing conditions and newly diagnosed Chronic conditions cover will be provided under this scheme after twelve (12) months from the commencement date.
- v) Elective surgeries will be covered under this scheme after twelve (12) months from the commencement date.
- vi) Organ transplant will be provided under this scheme after twenty-four (24) months from the commencement date.
- vii) Waiting periods shall not apply to any Insured member who was already on an identifiable and verifiable previous insurance cover.
- viii) There shall be an option for members to choose an insurance package that waives the waiting periods on outpatient pre-existing and newly diagnosed chronic conditions. This package will also limit the waiting periods on inpatient pre-existing and newly diagnosed chronic conditions to three (3) months. Such a waiver will attract a commensurate mark up in payable premiums as per provided pricing.



#### **10.** General Exclusions

**PE1:** Abuse of alcohol, drug, any other intoxicating substance, or any addictive condition of any kind and any medical condition arising directly or indirectly from any such abuse or addiction not limited to Admissions for rehabilitation.

**PE2:** Any type of infertility treatment, contraception, sterilization or fertilization, treatment for sexual problems (including impotence, whatever the cause), sex changes, assisted reproduction (E.g., IVF treatment) and any pregnancy, including surrogacy, resulting from such treatment.

**PE3:** Experimental or unproven treatment unless the Company has given specific pre-authorization.

**PE4:** Cryopreservation, implantation, or re-implantation of living cells or living tissue, whether autologous or provided by a donor.

**PE5:** Injury or Illness caused by, contributed to, or resulting from self-infliction, or willful exposure to danger.

**PE6:** Medical conditions sustained by military, naval or air force personnel resulting from participation in any military, naval or air force operation or exercise, participation in war, riots, strikes, lockouts, civil commotion, rebellion, revolution, insurrection, terrorism, military or usurped power or any illegal/criminal act, including resulting Imprisonment.

**PE7:** The release of weapon(s) of mass destruction (nuclear, biological, or chemical) whether such involves an explosive sequence(s) or not.

**PE8:** Contamination from chemical, biological, and nuclear materials, including waste products from the combustion of nuclear fuel.

**PE9:** Treatment by chiropractors, acupuncturists, and herbalists, stays and/or maintenance or treatment received in nature cure clinics or similar establishments or private beds

registered within a nursing home, sanatoria, convalescent and/or rest homes or 'cures' attached to such establishments.

**PE10:** Medical Conditions due to the participation in professional and hazardous sports including but not limited to scuba diving, sky diving, parachuting, paragliding, mountaineering and martial arts, or use of weapons or firearms.

**PE11:** Learning difficulties and/or disorders, developmental disorders, and speech/or voice problems.

**PE12:** Cosmetic, reconstructive, or remedial disorders, whether or not for psychological reasons, and/or any complications arising thereafter including and not limited to removal of fat from any part of the body, keloid, scars and birthmark removal, breast reduction or breast enlargement, ear or body piercing and tattooing, and any treatment required following these.

**PE13:** Routine medical examinations and regular check-ups, unless explicitly included as part of the scheme agreed by the member's employer.

**PE14:** Circumcision unless medically necessary for the treatment of disease/injury not excluded in the Policy.

PE15: \*Vaccinations.

**PE16:** Sex hormone replacement therapy, use of steroids, organic preparations and their derivatives except in management of non-hormonal conditions e.g. Cancers and related conditions.

**PE17:** Treatment in any quarantine/isolation or rest home, spa, hydro-clinic, health resort, massage center and chiropractic treatment, sanatorium or long-term care facility that is not a hospital.

PE18: Abortion due to voluntary, psychological, or social reasons, and its consequences.

PE19: Sunglasses and Plano lenses.

**PE20:** Natural or non-medical degenerative defects but not limited to sight, hearing and bone.

**PE21:** Preventative dental examinations, prophylaxis treatment, dentures, false teeth, dental implants and/or orthodontic treatment.

**PE22:** Obesity, special diet, or weight control, compulsive or addictive eating disorders and/or homesickness.



**PE23:** Children's food, baby supplies, vitamin, mineral or organic supplements, de-wormers, products that can be purchased without a doctor's prescription such as, but not limited to, mouthwash, toothpaste, antiseptic lozenges or sprays, shampoo, sunscreen, etc.

**PE24:** \*Supplying, maintaining, or fitting any external prostheses or appliances, rental or purchase of crutches, wheelchairs, or other equipment, medical or otherwise. The Company will pay for spinal support, knee brace, collar brace, etc. if it is part of a surgical operation and/or integral to the treatment of a covered medical condition.

**PE25:** Charges or fees incurred for the completion of medical claim forms and any provider registration fees and medical report charges unless requested by the Company.

**PE26:** \*Any treatment relating to a condition that the insured person was aware of (ought to have known) at the commencement date, which was not disclosed to us, and accepted by us.

**PE27:** Medication, drugs, and dressings which are not recognized by the National Drug Authority of Uganda or are available without prescription from a medical practitioner, specialist/consultant, registered nurse, or therapist.

PE28: Treatment as a result of proven medical negligence or malpractice.

**PE29:** Medical certificates and examinations for residence, employment, or travel.

**PE30:** Treatment for national disasters, pandemics, and epidemics.

**PE31:** Permanent family planning methods such as tubal ligation, vasectomy, or the reversal of such procedures.

**PE32:** Prophylactic treatments and Allergic tests.

**PE33:** All transportation costs occurring during trips specifically made for the purpose of obtaining Treatment, any other non-medical items that are not required for treatment will not be catered for by the Company e.g. phone calls, DVDs, airtime, internet, newspapers, diapers.

**PE34:** All costs relating to appointments not kept or cancelled by the Insured or Insured dependents.

**PE35:** All costs relating to interest charged and legal fees arising out of overdue medical expenses.

**PE36:** Any costs incurred in the pursuit of any legal action against us.

**PE37:** All costs relating to appointments not kept or cancelled by the Insured or Insured Dependents.

**PE38:** All costs relating to interest charged and legal fees arising out of overdue medical expenses.

#### **Exclusions of Covid-19 Cover**

1. Costs of quarantine and mandatory Covid-19 tests for non-positive cases.

- 2. Self-lab-requests are not covered.
- 3. Cost of tracing contacts is not covered.

4. Preventative treatments are not covered.

5. Presumptive treatments for Covid-19 negative cases will not be covered
